This letter is sent in our capacity as counsel for the Receiver of Meritus Mutual and of MHP. It provides notice of a Setoff and Claim Determination as to Meritus Mutual and to MHP, respectively, and seeks a response on or before Monday, December 18, 2017.

We received your claim dated May 9, 2017 making a broad assertion of claims by and on behalf of the United States. As you may know, we also received specific claims from Centers for Medicare and Medicaid Services ("CMS") against Meritus Mutual and MHP. Because of the general nature of the claims asserted in your May 9, 2017 Proof of Claim ("POC"), the claims you asserted could be perceived as duplicative of the more specific claims asserted by CMS.

The Receiver has made claim determinations regarding the CMS claims and has provided notice of those determinations to the CMS claimants. Copies of those notice letters are being provided to you. To the extent the claims addressed in these notices are also included in your POC, then please consider the notice letters applicable to such claims as determinations by the Receiver.

In that event, on or before Monday, December 18, 2017 please notify the Receiver of your response to the Receiver's determination. To the extent you object to such determinations, please support your position.

A hearing will be scheduled at least 60 days after the date of this letter. We will send you notice of the hearing after it is scheduled. At that hearing, the Receiver will ask the Receivership Court to approve the Receiver's determination.
