- 9 3. The MHP Receiver and/or the Special Deputy Receiver is authorized to deposit an
10 amount up to \$50,828.94 into the Receivership Liquidation Fund, which amount is
11 equal to ten percent of the original amount of MHP's deposit of \$508,289.39.
