2. The Meritus Mutual Receiver and/or the Special Deputy Receiver are authorized to deposit an amount up to \$50,828.94 into the Receivership Liquidation Fund, which amount is equal to ten percent of the original amount of Meritus Mutual’s deposit of \$508,289.39.
3. The MHP Receiver and/or the Special Deputy Receiver is authorized to deposit an amount up to \$50,828.94 into the Receivership Liquidation Fund, which amount is equal to ten percent of the original amount of MHP’s deposit of \$508,289.39.
