20 This Notice of Substitution is filed pursuant to and in accordance with Rule 25(d) of
21 the Arizona Rules of Civil Procedure. Evan G. Daniels has resigned from the position of

27 2016.

28 Rule 25(d), A.R.C.P., specifically addresses these circumstances, as follows:

1 An action does not abate when a public officer who is a party in
2 an official capacity dies, resigns, or otherwise ceases to hold
3 office while the action is pending. The officer's successor is
4 automatically substituted as a party. The public officer's counsel
5 must file a notice of the substitution, and later proceedings should
6 be in the substituted party's name, but any misnomer not affecting
the parties' substantial rights must be disregarded. The court may
order substitution at any time, but the absence of such an order
does not affect the substitution.

7 Accordingly, counsel has modified the caption to reflect the substitution and has
8 provided notice of the substitution in accordance with Rule 25(d), A.R.C.P.
